Some Techniques For COMBINING SENTENCES

A CLAUSE Is A Group Of Words Having A Subject And A Predicate And Forming A Part Of A Sentence. There Are Two Main Kinds Of Clauses -- Independent (or Main)-- Makes Sense By Itself, And Dependent (or Subordinate)-- Does Not Make Sense By Itself.
