TRADE IN SERVICES - World Trade Organization

In 2014, Trade In Services Totalled USD 4,800 Billion, Representing 21 Per Cent Of World Trade In Goods And Services. However, This Total Does Not Cover Services Delivered Via Foreign Affiliates (i.e. Essentially Mode 3). The Total To Be Much Larger, Even Twice As Large, As Mode 3 Represents 55 Per Cent Of Total Services Trade (see Figure 2). Feb 1th, 2022
